In recent years a large number of highly skilled professionals like doctors, engineers and IT professionals from poorer countries are migrating to developed countries for better-paying jobs.

What are the possible problems of this and what solutions can you suggest to deal with this issue?

It is generally seen that quite a large number of people with advanced and professional skill set like doctors, engineers and IT professionals from developing nations are moving to developed countries like US, UK, Australia etc (don't write etc,write UK and Australia)for higher and better pay in recent times. To begin with, the main reason for these highly skilled professionals(LR-repeating-can use executives, experienced, qualified) migrating, (GRA) is for better salary and high standard of living. I am of the opinion that a nation can be better developed only if it allows skilled participants to be a part of its

country(LR-nation,place,territory,homeland) and thereby contribute for (GRA-wrong preposition-'to' is correct)its advancement. In addition, the highly adept work force (GRA-workforce)

practicing in the medical industry are(GRA-singular-is) working in renowned hospitals and (GRA-conjunction to be used)are(GRA-singular-is) offering service to the citizes (GRA-spelling-citizens)of

developed countries itself. There is no doubt migrating to the Western nations would offer them better pay checks(GRA-paycheck) but it is only after rigorous immigration process and following a series of examinations that they are able to enter the country. However it is generally believed that the people migrating fromdeveloping(LR-evolving,growing,advancing,progressing)nations grab the employment opportunities of the local community. While it is true to some extent, it seems to me that

only the jobs for which native citizens are ineligible due to lack of qualification and skill set are being offloaded to the immigrants. To be precise, the jobs that are vacant due to unavailability of skilled work force and thereby the innovative fields like product development and consulting which(GRA-relative pronoun)are deprived of

manpower are only being awarded to non-native people. It is also to mention herewith that the sacrifices done by the migrants is also to be taken into consideration before evaluating them as they are (GRA-pronoun and verb)just moving ahead only for better salary. They leave their families, parents, ancestral property and all the more their own culture and tradition of their community(CC-repeat ideas) to work in a completely unknown nation. In order to have control and restrict the less skilled manpower to(GRA-wrong preposition-use from) migrating into advanced countries, the

developing nations can ensure strict immigration laws and enforce stringent visa stamping procedures and hence permit only immigrants of good quality are allowed(CC-repeat ideas) into their country. Further, the

organization which has certified that the recruitment for a foreign national is done has to be legally prosecuted in case a local citizen can perform the similar nature of duty. In addition, the firm's (LR-wrong word)license

may be annuled (GRA-spelling-annulled) by the administration for resorting to such illegal practices after issuance of a series of warnings, duly demanding a response for such malafied (GRA-malafide) intentions.

To summarize, I would like to reiterate that even though adept(LR-expert,gifted,proficient) professionals(LR-competent,accomplished,efficient)like doctors and software engineers are migrating to developing (LR-wrong word-developed,prosperous,evolved,flourished)nations, it is only for better pay and high standard of living(LR-lifestyle,quality of life,level of affluence) and(GRA-but) this comes at the cost of a lot of compromises like leaving the native country.
