#### Dear Ritesh

We are pleased to extend this Letter of Intent (LOI) to formally appoint you as a part-time trainer for our online portals, subject to the terms and conditions outlined below. This LOI signifies our intention to collaborate with you for the development and delivery of educational content.

### 1. SCOPE OF WORK:

As the Expert in the field, you agree to develop high-quality educational content for our educational portals in accordance with the provided guidelines and module framework. The services include but are not limited to:

- a. Developing a course with elements such as course outline, course outcome, syllabus, study material, and multimedia components.
- b. Creating video content.
- c. Delivering live teaching and training.
- d. Skills development and training.
- e. Providing one-on-one training and counselling.
- f. Developing and accessing assignments.
- g. Assisting with job/HR preparation.

### 2. DELIVERY SCHEDULE:

a. Design and submission of the course framework (No. of module/course outline/assessment etc) and objectives for approval after signing of LOI.

- b. Students' registrations will commence 15 days after the delivery of the first three modules completed in every manner.
- c. Submission of a minimum of 1 module per week.
- d. Conducting live classes as per the mutually agreed schedule.
- e. Prior notice for any rescheduling of live classes.

## 3. COMPENSATION STRUCTURE:

- a. The company will pay Rs. 600/- per hour for live classes as well as for Recorded material (videos)
- b. The company will share 2% (as an incentive) of the overall registration amount in the courses executed by you.

OR

a. 20% for each registration in any new course that is produced by you. After 3 years of course from the date of first registration, if the course remains alive then the payment percentage will be mutually discussed and applied.

# 4. INVOICES:

- a. Submission of invoices on or before the 30th of every month, payment will be processed within 10 days.
- b. The company will pay 75% of the total amount and the rest 25% will be added to next month's payout (e.i., let the first Month's total Payout is 10000/- then the company will pay 7500/- in the present month and 2500/- will be added in next month). In the same way, payment will be transferred to the trainer till the trainer works with us.
- c. TDS deduction as per government laws.

- **b.** You will be fully responsible for the completion of the course. If in any circumstances courses are not completed then the trainer has to refund

the total amount received from the second party with 18% interest to

portals as a trainer and an expert.
